The Balanced Increasing Dividend Equity Account (IDEA) 60/40 strategy was inceptioned on September 1, 2011, and the Balanced Increasing Dividend Equity Account (IDEA) 60/40 Composite was created on April 1, 2023. Confluence Investment Management LLC is an independent registered investment adviser. Results are based on fully discretionary accounts under management, including those accounts no longer with the firm. Past performance is not indicative of future results. The U.S. Dollar is the currency used to express performance. Returns are presented gross and net of all fees and include the reinvestment of all income. Gross returns are shown as supplemental information.

\*Net-of-fee performance was calculated using the highest applicable annual bundled fee of 3.00% applied quarterly. This fee includes brokerage commissions, portfolio management, consulting services and custodial services. The Confluence fee schedule for this composite is as follows: 0.52% on the first \$500,000; 0.47% on the next \$500,000; and 0.42% over \$1,000,000. There are no incentive fees. Clients pay an all-inclusive fee based on a percentage of assets under management. The collection of fees produces a compounding effect on the total rate of return net of fees. Bundled fee accounts make up 100% of the composite for all periods. Actual investment advisory fees incurred by clients may vary. Wrap fee schedules are provided by independent wrap sponsors and are available upon request from the respective wrap sponsor.

Effective September 1, 2025, the benchmark indices for this composite were retroactively reassigned: the primary index was changed from the 60% S&P 500 Index 40% BB-Agg Index to the 60% Russell 3000 Value Index 40% BB-Agg Index, and the secondary index was changed from the 60% Russell 3000 Value Index 40% BB-Agg Index to the 60% S&P 500 Index 40% BB-Agg Index.

A complete list of composite descriptions is available upon request. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request. The annual composite dispersion is an equal-weighted standard deviation, using gross-of-fee returns, calculated for the accounts in the composite for the entire year. The three-year annualized standard deviation measures the variability of the composite gross returns over the preceding 36-month period. The Balanced IDEA 60/40 Composite contains fully discretionary Balanced IDEA 60/40 wrap accounts. Balanced IDEA 60/40 combines equity and fixed income allocations in a single account. The equity portion is selected from a universe of stocks, from all market capitalizations, meeting minimum criteria of paying and increasing dividends over the last 10 years. The fixed income portion is invested in taxable fixed income Exchange Traded Funds (ETFs), diversified across maturities and sectors.

The custom benchmarks are calculated monthly and consists of a blend of 60% Russell 3000 Value and 40% Bloomberg US Agg Bond Index, while the other consists of a blend of 60% S&P 500 and 40% Bloomberg US Agg Bond Index (Source: Bloomberg).
