

Business Cycle Report



The business cycle has a major impact on financial markets; recessions usually accompany bear markets in equities. The intention of this report is to keep our readers apprised of the potential for a recession, updated on a monthly basis. Although it isn't the final word on our views about recession, it is part of our process in signaling the potential for a downturn.

August 24, 2023

The Confluence Diffusion Index stagnated in a sign that the economy is still not in the clear. The July report showed that seven out of 11 benchmarks are in contraction territory. Last month, the diffusion index was unchanged at -0.1515, slightly below the recovery signal of -0.1000.


- Renewed optimism about the economy boosted stock prices.
- Higher interest rates led to a slowdown in homebuilding.
- The labor market is tight, but there are signs that hiring is starting to cool off.




The chart above shows the Confluence Diffusion Index. It uses a three-month moving average of 11 leading indicators to track the state of the business cycle. The red line signals when the business cycle is headed toward a contraction, while the blue line signals when the business cycle is in recovery. The diffusion index currently provides about six months of lead time for a contraction and five months of lead time for recovery. Continue reading for an in-depth understanding of how the indicators are performing. At the end of the report, the *Glossary of Charts* describes each chart and its measures. In addition, a chart title listed in red indicates that the index is signaling recession.


Consumer Confidence

Three-Month Average Manufacturers' New Orders Nondefense Capital Goods excluding Aircraft




- The 12-month moving average of the annual change in consumer confidence improved from -6.20 to -1.91.
 - Consumer confidence came in at 117.0, up from 95.3 in July 2022.
 - In the same period, the Present Situation Index rose from 139.7 to 160.0. Meanwhile, consumer expectations rose from 65.6 to 88.3.
 - The recession indicator is zero.

- The Wilshire 5000 Total Return Index rose 14.7% from the prior year.
 - Top-performing sectors: Energy, Communication Services, Financials.
 - Bottom-performing sectors: Health Care, Real Estate, Consumer Staples.
 - The recession indicator is zero.

- The three-month moving average of the annual change in new orders for nondefense capital goods fell 2.62% from the prior year.
 - In July, new orders rose 0.23% from the prior month but declined 2.24% since 2022.
 - \circ The recession indicator is zero.


10-Year Treasury Constant Maturity Minus Federal Funds Rate



36-Month Moving Average Change for Housing Starts




ISM Manufacturing: Supplier Delivery Index



- The financial spread, the 10-year minus effective fed funds, inversion narrowed from -1.33% to -1.22%.
 - The effective fed funds rate rose from 5.08% to 5.12%.
 - The 10-year Treasury increased from 3.75% to 3.90%.
 - \circ The recession indicator is zero.

- The 36-month moving average change for housing starts slipped from +3.67 to -2.14.
 - Housing starts expanded at an annualized rate of 1,452k, above the previous month's revised pace of 1,398k.
 - Single-family starts rose from 921k to 983k. Multi-family dwellings decreased from 477k to 469k.
 - The recession indicator is zero.
- The six-month moving average of the Supplier Delivery Index rose from 44.9 to 45.0.
 - The overall index rose from 46.0 to 46.4.
 - The Supplier Delivery Index increased from 45.7 to 46.1.
 - \circ The recession indicator is 50.


Twelve-Month Sum of Nonfarm Payrolls



Real M1 Money Stock




10-Year Treasury Minus Three-Year Treasury




- The 12-month moving sum decreased from 3,743k to 3,362k.
 - Nonfarm payrolls showed that the economy added 187k jobs in July.
 - Service-Providing industries added 154k jobs. The Goods-Producing sector added 18k jobs, while the Government sector gained 15k jobs.
 - \circ The recession indicator is 1,500k.

- Real M1 money stock fell 13.6% from the prior year.
 - Headline CPI rose 3.2% from the prior year.
 - M1 money stock fell 10.4% from the prior year.
 - \circ The recession indicator is zero.


- The term spread between the 10-year and three-year inversion deepened from -0.52 to -0.57.
 - 10-year Treasury increased from 3.75% to 3.90%.
 - Three-year Treasury increased from 4.27% to 4.47%.
 - \circ The recession indicator is zero.

- The two-year difference in the unemployment rate fell slightly from the previous report of 2.3% to 1.9%.
 - The unemployment rate fell from 3.6% to 3.5%.
 - The number of unemployed declined 2.0% from the prior month.
 - The recession indicator is zero.

Weekly Initial Claims



- Average weekly claims for July fell from 254k to 229k.
 - The recession indicator is 350k.

Glossary of Charts

Consumer Confidence: The Consumer Confidence Index is an economic indicator that measures the level of consumer optimism about the overall state of the economy and consumers' personal financial situations. This chart shows the 12-month moving average of the annual change of the index.

Wilshire 5000 Index: This chart shows the annual change in the Wilshire 5000 Total Return Index, which is the broadest U.S. equity index. The index contains 3,500 stocks and is designed to track the overall performance of the U.S. stock market. It is an important indicator because steep equity pullbacks have often coincided with economic contractions.

Three-Month Average Manufacturers New Orders Nondefense Capital Goods excluding Aircraft: This chart shows the annual change in the value of core capital goods orders. This indicator gives insight into the amount of business investment spending. A positive report suggests that manufacturers are optimistic about future demand.

10-Year Treasury Constant Maturity Minus Federal Funds Rate: This chart shows the spread between the 10-year maturity and the Fed funds rate. It reflects the market sentiment of the future state of the economy. Generally speaking, a negative spread suggests a contraction is likely to occur within 24 months.

36-Month Moving Average Change for Housing Starts: This chart shows the 36-month moving average of the annual change in housing starts. This is an important indicator because it provides a gauge of future construction activity. If housing starts are strong it implies that builders are optimistic about future demand.

ISM Manufacturing (Six-Month Average): The ISM Manufacturing Index is a report that monitors employment, production, inventories, new orders, and supplier deliveries. This index specifically focuses on the six-month moving average of supplier deliveries section in ISM, which we believe is a good gauge of future levels of manufacturing activity. A reading above 50 signals that manufacturing activity is expected to expand, while a reading below 50 signals that manufacturing activity is expected to contract.

Total Nonfarm Payrolls: This chart shows the 12month moving sum of total nonfarm payrolls. This report represents the total number of workers added to the workforce, excluding proprietors, private household employees, unpaid volunteers, farm employees and incorporated self-employed. It is a significant indicator of the strength of the labor market. A moving sum that exceeds 1,600 suggests the demand for labor is intense.

Real M1 Money Stock: The Real M1 Money Stock report measures the annual change in the money supply minus inflation. M1 is the measure of currency in circulation and represents the amount of money being held for transaction purposes, therefore it can act as a proxy for economic activity.

10-Year Treasury Minus Three-Year Treasury: This chart shows the spread between the 10-year and three-year Treasury and gauges investor sentiment. A widening spread suggests investors are optimistic about the state of the economy, whereas a negative spread suggests pessimism. This indicator is less sensitive than the financial spread as it is less affected by the Fed's decisions.

Two-Year Difference in the Unemployment Rate: The two-year difference in the unemployment rate measures the amount of slack in the labor market. When the difference of the twoyear unemployment rate falls below zero, it indicates the labor market is becoming less tight.

Weekly Initial Claims: This chart shows the fourweek moving average of initial jobless claims. A rising initial claims number means the demand for labor is weakening, likely due to a worsening business environment. If the four-week moving average rises above 350K, it signals the economy may be headed toward a contraction.
